The Menard County Prescribed Burn Association (MCPBA) is a non-profit 501-c3 organization with membership open to any Menard County landowner. The Menard Association is one of the oldest and largest sub-chapters of the Edward Plateau Prescribed Burn Association (EPPBA). The EPPBA originated in 1998 at the Texas AgriLife Research Station between Sonora and Rocksprings. Thus, all members of the MCPBA are also members of the EPPBA... and entitled to all benefits of the EPPBA.

The purpose of the burn association is to enable ranchers, county officials, volunteer fire departments, and other state and/or federal government agencies to work successfully together to improving our rangeland ecosystems. The formation of this neighbor-helping-neighbor cooperative has provided the resources, education, and encouragement necessary to help restore fire to rangelands on a sustained basis.
